WHAT DO A FEW FINGERS MEAN TO A COMPANY LIKE J. P. STEVENS?

KATHY PEACE, 18 YEARS OLD, NO EXPERIENCE. She was running a tufting machine in the Riverine plant at J. P. Stevens. Kathy had not been given any kind of instructions on how to run this machine. She had only been working on it about an hour and 45 minutes when she lost two fingers.

"Since I lost my fingers I have this fear of people seeing my hand. I'm a woman and . . . it upsets me now when I see people."

She's not able to work. Nobody does anything for her. No Rehabilitation. Nothing done to salvage her.





RICHARD GREGORY, 17 YEARS OLD, FIRST JOB AT J. P. STEVENS. He had been working with the machine about a week when he was hurt. The danger was never explained to him.

"I was pulling the carpet. It slapped over.
When it came loose I just fell down on those
rollers and caught my hand. Lost my fingers."

Then they told me they didn't need me. They let me go.
