#### Final steps

Elections to determine a winner in each category will be held online Nov 1-6. Members will receive their online ballot at their home email. If you do not currently receive email at your home email from our union, please email us at 88cabinet@afscmelocal88.org to let us know. This will help ensure that you receive all union communications including the ballot.

Winners in the officer elections will

be first announced to current Local 88 cabinet officers Nov. 6, then all candidates will be notified. After communication with the cabinet and candidates, the results of the election will be posted on the Local 88 website or may be sent to all members via action network.

### AFSCME Local 88 Executive Board — Uncontested races

Per the AFSCME international constitution, in all uncontested races the candidate is declared elected and is immediately installed. (Installation into office will not take longer than 10 days). Installation of a candidate who wins by acclamation is not required to wait for the rest of the elections to be tabulated.
