#### DEBRIEF **AFSCME International Convention** in Los Angeles

This is our union's biannual international conference. The officers and other delegates found value in meeting and learning about other locals and getting a better understanding of what other contracts contain, especially in locals with similar work and size. The training and networking allowed for some really great opportunities to talk to other union leaders about strengths and weaknesses in our unions. We gained knowledge on the financial needs of our union, as well as some invaluable new tools for member outreach and bargaining. The following members did an amazing job addressing resolutions/amendments at the conference and volunteering:

- Manuel Arellano spoke against book banning in libraries and protecting library workers.
- Imogen Fox spoke against Project 2025.
- Hilary Zust spoke about climate change and the impact on our work and communities.

Vice President Kamala Harris' running mate Tim Walz was the keynote speaker. And Local 88 member Amy Simpson won the international "Never Quit" service award. Amy is a mental health specialist at Central City Concern who relies on her own struggles and experience to connect with her clients. "I help bridge the gap between addiction services and domestic violence services, and I'm an art therapist and drug and alcohol counselor," said the Oregon AFSCME member in a video shown during the 46th AFSCME International Convention. "I present them with media and options to explore and express, and it creates an atmosphere of ease and trust where I think they feel comfortable to start talking."
