Multnomah County Bargaining

Our bargaining team consists of our president, eight members, and one AFSCME staff person.

Our bargaining team leads are AFSCME Local 88 President, Jackie Tate and Oregon AFSCME Program Manager, Christopher Johnson. The president is automatically a member of the team per the Local 88 constitution, and Chris serves as our lead negotiator.

Bargaining Team election results: All bargaining delegates were able to vote for up to eight candidates. Candidate statements were shared with the delegates to inform them on each one's department, race, gender, identities held and why they wanted to be on the bargaining team. The goal was to elect a diverse bargaining team tasked with representing all members at the bargaining table. What is the MAT?

Simply put, a Member Action Team is a tool to communicate with members and mobilize members around issues they care about. The communication is a two-way process, allowing union and bargaining leadership to relay important information to the members, and allowing members to send feedback and suggestions back to the leadership. When the decision is made to have a union action, MAT will ensure strong turnout and member participation for the event.

Meet Christopher "Chris" Johnson Oregon AFSCME Program Manager

Before coming to work for Oregon AFSCME, Chris was the organizing director for a local healthcare union, and a national representative for the American Federation of Teachers, with a focus on organizing new unions and bargaining first contracts. Chris got his start in the labor movement working as a firefighter for the Albany Fire Department. Chris grew up in Portland, where he lives with his family.

Member Profile: Ebony Klinger



Periodically we profile AFSCME Local 88 members who share aspects of their personal, work, and union life so you can learn their story. For this profile, we invite you to get to know Ebony Klinger, longtime county employee and union activist.

Who are you and how did you get to where you are?

My name is Ebony Klinger. I'm originally from Bellevue, Washington, east of Seattle. I moved to Vancouver, Washington in 1999 with my husband Kevin and two young daughters, Ariel and Alysha. I became a dental hygienist in 2011 and wanted to do more for my community, so in 2016 I went to work for Multnomah County.

What motivates you to be active in our union? What does being a union member mean to you?

My godfather was very big in his union and talked about it often. I worked for a

corporation for 16 years, rarely missed work and rarely took any medical leave. Then, I got really sick and was out of work for a month. And within that month I lost all my benefits because someone pressed the wrong button. I was denied any care or benefits or pay from my disability even though it was all settled. If I had had a union, this would have never happened to me. It motivated me to leave the corporate world and it motivated me to play an integral part in making sure people got a fair shake and not be taken for granted, meaning fair labor rights and equitable working conditions. Being a union member means being a part of a large family that looks out for each other. I've been in the union now for eight years. I started out as a member and then a steward which eventually led me to being on the executive board and doing VMO work, which was a really great experience. I have met

some amazing people. I still have a lot to learn, but I'm willing to roll up my sleeves and do the work. I think everyone should get involved in the union. There is more to it than grievances and negotiations. It is really rewarding when you help someone to understand the contract language or organize a meet-and-greet. It takes all of us. Like a family, we are stronger together, and if we all work together they can't put us off. They have no choice but to listen.

What are you working on or what's coming up that you're looking forward to?

I'm looking forward to doing more for my AFSCME Local 88 family, becoming more involved in the day-to-day workings of our union. I'm currently doing market adjustment bargaining, and next year I'd love to learn contract negotiations. Personally, I'm about to celebrate my 50th birthday, and that's very exciting.
